	• The Dean is campaigning to show we need to do better job of messaging: <b>the COE produces a very high quality product!</b> "COE is more than anyone knows" and a new brochure <b>52493</b> captures CoE highlights. Senators received copies, which are available from the Dean's Office. CoE talking points regarding issues that have been questioned:

	• 350 to 360 freshmen entered the college. The college enrolled 1,950. Next year enrollment is expected to be	

2200 to 2300—coincidentally, the same number of students enrolled at West Oahu.

• Legislative Update: The CoE is supporting early learning bills—all 3 have passed both house and senate. These are the Chairs for the various education committees, 2013:

- National Council on Teacher Quality (NCTQ) and Dean's rebuttal were distributed to the Senate. While Hawaii's education system was not viewed favorably, neither were other states. No state received a grade higher than a B-. The legitimacy of the NCTQ is in question and is not recognized by the DoE. The report received little media coverage.
- New 6-month pilot program under leadership of Tom Apple: Deans now have authority to approve APT appointments and determine compensation—exception is IT positions are not included in this pilot. Dean
- The following faculty have received URC awards: Drue Narkon, Laurie Fulton (also honored with Dissertation of the Year Award), Julie Kaomea, Ron Heck. Congrats all!

Common Course Numbering

Guest: Joanne Itano, Associate VP, Academic Affairs

- The All Campus Council Senate Chairs (ACCFSC) drafted a process of Common Course numbering (Sp 2012) to ensure the smooth transfer of courses across the UH campuses, *in the best interest of students*.
- Common Course numbering will only apply to Foundational courses, and likely will have minimal effect on COE courses.
- The ACCFSC looked at proposal again year—which fell apart when taken back to campus for approval. 9 campuses approve of and one, Manoa does not. The ACCFSC wanted feedback from the colleges.
- The discussion has pitted Community colleges against the Universities and centers on the terms student

learning **outcomes** versus student learning **objectives**. The term "Outcomes" was going to be used system wide because it is in the interest of the student, but Manoa disagreed and wanted "objectives" to be used. Manoa faculty felt there should be shared responsibility for learning between students and faculty, and this is not captured in "outcomes."

• For accreditation, the term "outcomes" is required.

#### David Ericson

- New landscape plan, go to Facilities webpage—
   Facilities cannot hire and cannot keep up with what we already have and want to plant new shrubs and trees.
- Financial/Kathy Cutshaw. All student tuition moved to general funds to cover salaries. If this money disappears we'll be at the mercy of the legislature. There are a couple proposals under review: 1. Remove the President's procurement authority, and 2. Have one general counsel for UH. Additional legal services would be procured from the State Attorney General's office.
- Graduate Education will move to Vice Chancellor of Academic Affairs (VCAA).

## Truc Nguyen—360 Review

- The 360 review for administrators attempts to maintain transparency and uphold Privacy Laws. UHM follows the University of Michigan model.
- The 360 Review for Dean's is at Manoa HR. Traditionally, faculty participation has been low.
- Not every Dean receives a review because UHM HR is overwhelmed. A review is done for several administrators every 4 years. There can be an expedited review as requested, which can occur annually.
