## **Report from the Chair**

Chair O'Neill led a discussion on the Memorandum of Agreement between UHPA and various faculty senates regarding consultation protocols. The original deadline to have this was by December 2014. UHPA then came forth with a draft version after this. Chair O'Neill thanked everyone who did submit feedback on this.

# **Dean's Report**

Dean Young thanked Chair O'Neill for her leadership in planning the Back to School Night event, as the faculty support and turnout by faculty was fantastic. He said that they will try to find a way to share what was featured at the event of our colleagues. Nine legislators came, and Chair O'Neill and Dean Young walked the Capitol between holidays and hand-delivered invitations to go to the legislators. With the ons that came, he believes we achieved our results. On Opening Day, he made a point to go to each of the legislators who did come to the Back to School Night event who did attend.

Dean Young discussed a few main topics. First, he discussed the tremendous developments of the facilities. A development plan for property that was submitted by Group 70 back in June 2014 includes renditions of what new buildings might look like. There will be a meeting with Group 70 to review the plan. Dean Young also discussed the FROG project installation phase two. The last topics relating to the COE was the Wist and Everly AC installations. He said they are ahead of schedule, and Wist will be near completion by the end of next week.

Dean Young said that the Board of Regents (BOR) yesterday approved the UH System strategic initiatives. He encouraged everyone to read that document. President Lassner outlines four strategic initiatives.

The Dean's Council is also sponsoring the Conversation with the Dean this month.

## **Report from Committees**

### Committee on Curriculum and Program Planning

Senators Chang and Lucas announced that they want to make students feel more welcomed to the COE community. They feel that students being invited would be appreciated to the Congress meeting.

#### Committee on Diversity

Senator Yuen reported for Senator Uyehara that Ruth Bar Signaye from the David Yellen College of Education in Jersualem, Israel, has been invited to speak, and it will be sponsored by the Diversity Committee. which is scheduled for Tuesday, February 24 at noon at the CCC.

# Committee on Fellowship

Senator Leong said he is hoping to get five dates for this semester's Congress meeting, and asked that everyone go back to their departments and units and at the next meeting there will be a vote on the final date. At the moment, the options are May 5, 7, 8, 14 and 15. He will get a list of faculty awards for the next meeting.

## Committee on Governance

Senator Yuen said they are still working on DGO survey and that there are a lot of changes at the DOE. This is now called the DGA. There is an opportunity to have David Moyer, the director come to discuss the vision and their proposed plan. There is a new system people are being recommended to go to.

# **Report of the ACCFSC**

Senator Ericson agreed to attend the meeting. There was a discussion about the UH System president and the UH-Mānoa chancellor being one position. He also gave an update of the Mānoa campus. There is a sustainability policy being created at the system-wide level. He also discussed labor practices and the creation of both student and faculty regents.

#### **New Business**

Chair O'Neill said that at the beginning of the year, she set to create a better sense of community in the COE, and to become stronger advocates for ourselves and believes we are achieving those goals. A few topics to consider taking up include building community around faculty and including students more, legislative relations and communication to share about classes. Regarding the legislative relations, there was discussion on legislative liaison being a part of this body.
